Regeneron Provides Update on Patent Litigation Against Samsung

Regeneron has reached resolution of our patent infringement litigation related to the Samsung EYLEA[®] (aflibercept) Injection 2 mg biosimilar product. The settlement allows Samsung to launch its biosimilar product in the U.S. in January 2027. All intellectual property-related litigation in the U.S. with Samsung will be dismissed. The financial and other terms of the agreement are confidential.

Regeneron has invested many years of effort into its design and development of EYLEA and remains committed to actively enforcing its intellectual property rights.
